



LIMITED WARRANTY

Austin EV, Inc. (AEV), 21 Cypress Blvd, Suite 1080, Round Rock, TX, 78665 gives a TWO YEAR or 8,000 MILE (12,900 km), whichever comes first, LIMITED WARRANTY on all components (except batteries) of your AEV vehicle against defects in material or workmanship.

Mileage is unlimited for the first 6 months of the vehicle warranty. Any time after month 6, the vehicle warranty expires at 8,000 miles (12,900 km) or at the end of the two-year period, whichever comes first.

This warranty covers the parts and labor charges for repair or replacement of defective parts and begins on the date of purchase by the original retail purchaser.

This warranty is transferable to another consumer during the warranty period through an AEV dealer, but any such transfer will not extend the original term of either warranty.

The duration of this warranty and / or the battery warranty may vary by international region based upon local laws and regulations.

BATTERY COVERAGE

Battery coverage in this Limited Warranty begins on the date of purchase by the original retail purchaser and continues for twenty-four months or 8,000 miles (12,900 km) on a declining balance basis, whichever comes first.

Mileage is unlimited for the first 6 months of the battery warranty. Any time after month 6, the battery warranty expires at 8,000 miles (12,900 km) or at the end of the two-year warrant period, whichever comes first.

During this time period, AEV warrants your vehicle's batteries against defects in materials or workmanship. After the first six months in service, a defective battery will be replaced on a manufacturer / customer shared basis provided that the warranty limit of 8,000 miles (12,900 km) has not yet occurred. Please review the below table for guidelines.

TERM FOR VEHICLES WITH LESS THAN 8,000 MILES (12,900 km)	WARRANTY COVERAGE FOR BATTERIES DEEMED DEFECTIVE BY AEV
Purchase Date through the 6th Month (inclusive) of Service	100% of the cost of an approved AEV battery at an AEV dealer
7th - 12th Month (inclusive) of Service	75% of the cost of an approved AEV battery at an AEV dealer



13th - 18th Month (inclusive) of Service	50% of the cost of an approved Austin EV battery at an AEV dealer
19th - 24th Month (inclusive) of Service	25% of the cost of an approved AEV battery at an AEV dealer

REGISTRATION

At the time of sale, the Warranty Registration Form must be completed by your dealer and submitted to AEV within thirty (30) days. Upon receipt of this registration, AEV will record the registration for warranty. No verification of registration will be sent to the purchaser as the copy of the Warranty Registration Form will be the warranty entitlement.

If you have not signed the original registration and received the customer copy, please contact your dealer immediately. **NO WARRANTY COVERAGE WILL BE ALLOWED UNLESS YOUR VEHICLE IS REGISTERED WITH AEV.**

Initial dealer preparation and set-up of your vehicle is very important in ensuring trouble-free operation. Purchasing a machine without proper dealer set-up will void your warranty coverage.

HOW TO OBTAIN WARRANTY SERVICE

If your vehicle requires warranty service, you must take it to a AEV Servicing Dealer.

When requesting warranty service, you must present your copy of the Warranty Registration form to the dealer.

THE COST OF TRANSPORTATION TO AND FROM THE DEALER IS YOUR RESPONSIBILITY.

AEV suggests that you use your original selling dealer; however, you may use any Austin EV Servicing Dealer to perform warranty service.

Please work with your dealer to resolve any warranty issues. Should your dealer require any additional assistance they will contact the appropriate person at AEV.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state. If any of the above terms are void because of state or federal law, all other warranty terms will remain in effect.



HOW TO GET SERVICE

Warranty or Service Bulletin repairs must be done by an authorized AEV dealer. If you move or are traveling within the country where your vehicle was purchased, Warranty or Service Bulletin repairs may be requested from any authorized AEV dealer.
